Music Study Grant Application



Information:

1. Grants will be awarded for instrumental instruction only (excluding keyboards).
2. The maximum amount will be \$400.
3. Awards will be given in both a junior (grades 5-8) and senior (grades 9-12) division.
4. Applications must be postmarked no later than **November 6, 2010**.

Qualifications:

1. Student must be at least 12 years of age or have at least one year of previous music study, and be participating in a public school music program.
2. Student must show a strong involvement in the study of music.
3. Student must demonstrate a financial need.
4. Student must reside in one of the counties served by MEAP, Inc.:

(In Oregon-Clatsop, Columbia, Tillamook, Washington, Yamhill, Multnomah, Clackamas, Marion, Linn, Hood River, Wasco, and Lincoln. In Washington-Cowlitz, Clark, Skamania, Klickitat, and Lewis)

Instructions to student:

1. Provide a personal letter describing your involvement in music - the importance of music in your life, drawing upon past experiences, present influences, and your goals and plans for the future. Be sure to express your financial needs: Specifically, what would a study grant make possible for you?
2. Provide a short letter of recommendation from your school music teacher, and, if you have one, your private music teacher.
3. Provide a short letter from a parent or guardian describing your family's financial need. Include a statement of your total yearly household income *or* proof of free or reduced school lunch. If you are living independently, you should include your description of financial need in your personal letter (see above, #1).
4. Provide a 2-5 minute cassette tape or CD that is representative of your ability (accompaniment is optional). Please label the recording clearly with your name, phone number, instrument and selection. If you send a CD, it must be in CD audio format, WAV, MP3 or WMA format.
5. Fill out the personal information requested on the **opposite side** of this form.
